Scapa 3492 is primarily a glass protection tape. The product is green. The foam is predominantly closed celled and is hard. An acrylic, low tack pressure sensitive adhesive is coated on one side, and the product has a removable polyester release liner on the other non-adhesive face. Scapa 3492 will act as a water-seal and air/dust seal when compressed.
